Northern Panhandle Project Sharing

Northern Panhandle Project Sharing was developed to assist nonprofit organizations, youth organizations, schools, and others serving underprivileged families, the elderly, those who are ill, and youth.

Project Sharing can provide food, clothing, school and office supplies, building materials, hygiene products, household goods, and more.



The program assists organizations in stretching their budget dollars further by providing tangible goods for use in their organization's mission.



Application Procedure

To become a participating organization, you must be an organization that works in one of the four counties we serve, helping the needy, those who are ill, the elderly, and/or youth. You may request an application or complete the application on this brochure. Once your application is approved, you will receive notification each time we have a distribution. Currently, we distribute products every four to six weeks.

Program Costs

At this time, we are requesting that your organization consider making a donation to Project Sharing to help offset our costs to operate the program. An average donation is \$20 per visit or \$150 annually. All donations remain with the Project Sharing program and are used for warehouse space rental, shipping and handling costs of products received, supplies, and general program operating costs.

Since June 2009, approximately \$750,000 in new products has been donated to over 40 organizations in Brooke, Hancock, Marshall, and Ohio Counties.

If your organization is not able to make a financial contribution, you can also provide service hours to this or other projects of the Northern Panhandle RC&D. Contact our office for arrangements.

Program Restrictions

Items received through Project Sharing must be used to serve youth, the elderly,

those who are ill, and those who are needy. Additionally, items may not be sold, bartered, or traded. Other program requirements are listed on the application.

Volunteer Opportunities

We welcome your interest in supporting our program by volunteering your time. We need volunteers to help unload delivery trucks, assist with inventory, drive to pick up product donations, and assist with loading vehicles on distribution days. Please contact our office for more information and to sign up to be a volunteer.
